And whereas they Trustees have at the request of the setter, agreed to act as the first trustees of these present as testified their being parties to and executing these present.

And whereas it is necessary to declare the aims and objects of the public charitable public Trust being constituted under these presents.

NOW THIS INDENTURE WITNESSETH AS FOLLOWS :-

1. That, in order to effectuate his aforesaid desire, the settler has set apart and handed over to the trustees, a sum of **Rs. 1,00,000/- (rupees one lakh)** (hereinafter called the trust Fund which expression shall include cash and any other property of investments of any kind whatsoever into which the same or any part there of might be converted invested or varied from time to time which may be acquired by the trustees or may come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents) and the trustees shall hold and stand possessed of the same upon the trust subject to the powers, provisions, agreements and declarations hereinafter contained.

That the name of the trust shall be **"SABARMATI GAYAN NIKETAN TRUST"** and office will be situated at **office** Vill+Post : Telhara, Dist : Nalanda (Bihar) and / or at such other place or place as the trustees may decide from time to time.

2. THAT THE OBJECTS FOR WHICH THIS TRUST IS ESTABLISHED ARE :

- (a) To set motion and play a proactive role in giving direction for a quiet social movement / revolution for socio economical, educational cultural, scientific, technical, financial ethical prosperity and take spearheaded initiative to spread the gain or prosperity in the benefit of throughout masses of world of living creature.
- (b) To organize, promote, undertake, sponsor, carry out all programmes for the benefit of naturally challenged person, schedule caste, schedule tribes, people under poverty line, old aged, widow and down trodden irrespective of caste, creed, sex and religions such as :-

I. IN THE FIELD OF HUMAN RESOURCE DEVELOPMENT :

- (a) To establish, develop, maintain schools, ITI under NCVT course, colleges, Para Medical Dental college, Pharmacy college, Engineering College, B.Ed. College, Teacher Training College, Medical College, Libraries, Universities, Laboratories, Skill development centers, competition, preparation centers, yoga and spiritual centers, sports, training centers, vocational and technical training centers research and other institutions for the development and advancement of education and diffusion of knowledge among the public in general.
- (b) To establish, maintain and run studentship, scholarship and award programme and render other kind of said to students including supply of study materials, books, stipend, medals and other incentives.
- (c) to organize programme for the promotion of preprimary education, non formal education, computer and information technologies, leadership development, techno entrepreneurship development educational infrastructure research, and development, socio scientific research management,
- (d) Publish study materials, magazine, books, information, materials, journals, produce film, T.V. serials, documentaries, audio- video cassettes on burring social, educational and scientific issues.

II. IN THE FIELD OF PUBLICATION & PRINTING

To run publication and printing of book, magazine, booklet and handbills to the general people and student.

III. IN THE FIELD OF SCIENCE & TECHNOLOGIES
COMMUNICATION & INFORMATION TECHNOLOGIES

- a) To carryout all the programmes science and Technology and communication Publication Information Technology for popularization, use and inculcation of scientific temper among the people Also ensure the use of technologies in the field of rural development appropriate technology, rural technologies, environment and ecology, non conventional energy, formal education, computer education. etc.

VII. IN THE FIELD OF RURAL DEVELOPMENT: -

- a) To promote education, training and research programmes in Rural Management and generate a Human Resource Force to settle the needs of people in rural areas.
- b) To organise, conduct, sponsor, the intensive programme on Rural housing. Rural finance, Marketing mechanism infrastructure development, Cottage & small scale industries development, co operative and cooperation, Integrated wasteland Development, Technology Development Extension and training programme, Investment Promotion Schemes for the promotion of rural infrastructure, watershed and water management and unutilised resource development programme, welfare and strengthening programme for marginal and underprivileged farmers, promotion of cost effective technologies, rural sanitation including low-cost latrines.

VIII. IN THE FIELD OF URBAN DEVELOPMENT :

- a) To undertake assist manage, organize the all programmes of urban development particularly public health engineering, slum community rehabilitation and development, civic amenities and public services, town planning , master plan preparation land implementation, water and hydrometric studies, research and management, sewerage and waste management.
- b) To establish and art of state centre for education, training and research in 'urban planning and development.
- c) To undertake different and effective measures for pollution and noise control awareness programme and work for its control.

IX

IN THE FIELD OF YOUTH AFFAIRS AND SPORTS.

- a) To carry out all the programmes / projects for the awakening of national integration, communal harmony, cooperation and co operative behaviour attitude development, moral and social habit development in the youth and to ensure participation in the development of nation and humanity.

IN THE FIELD OTHER PROGRAMMES. :

- (a) To undertake, organize, investigate, participate, sponsor, conduct, the human right programme, including awakening of human right, preservation, of fundamental right, protection and safeguards to the victims of human right violations, for the freedom, dignity and peace of people. Also undertake case study, research, publications, treaties with national and international institutions and foundation or endowment of award and prize for effective implementation of Human Right.
- (b) To encourage, promote or development alternative system of medicine i.e. Homeopathy, polypathy, Ayurveda Tynani, Yoga, Naturopathy, Meditation, acupressure, acupuncture etc. Also promote preventive and curative health services.

- (c) To organize or conduct all of the programmes of natural disaster management and ensure relief rehabilitation of victims and setup precautionary / preinformation mechanism of natural disaster.
- (d) To organize or run the programmes for the development of culture, tourism and national memorials, natural resources management, afforestation and eco development, environment education, environmental information system, technology up gradation/ establishment / modernization of food processing industries, quality assurance, market survey, test marketing and brand promotion, gender issues, promotion and brand promotion, gender issues, promotion of blood, eye and human limbs donation, promotion of Indian languages, prevention of atrocities on women, universalisation of elementary education rural energy programme, bio-gas development programme, khadi and small scale industries promotion, administering, road safety programmes, social assistance programme, promotion of rural non farm enterprises, rural and micro financing.

3. All the activities shall be Non Profitable and shall be done on No. Profit – No Loss basis.
4. All the incomes, earnings, movable / immovable properties of the Trust shall be solely utilized and applied towards the promotion of its Aims and objects only as set for in the deed of the Trust and no profit there of shall be paid or transferred directly or indirectly by way of dividends bonus, profits or in any manner whatsoever to the present or the past member of the Trust or to any person claiming through any one more of the present or the past members. No members of the Trust shall have any personal claim on any movable or immovable properties of the Trust or make any profits, whatsoever, by virtue of his membership.
5. That the Trust fund may be augmented by the income from the initial fund also by donations and other contribution from time to time.
6. That the Trust Fund shall not be applied for any purpose other than those specified in para-3 herein above unless the other objects added to the trust objectives.
7. That the Trustees shall always maintain proper accounts of the Trust, which shall be kept at the office of the Trust.
8. Subject to the provisions of Income Tax Act. 1961 as amended from time to time, the Trustees will keep the Trust Fund of such portion there of as they may in their absolute discretion, think fit and proper, without being answerable or accountable to the beneficiaries or any other property for any loss invested in such shares, stock, securities and debentures of acquisition or

- (iii) To sell, dispose of alienate or otherwise deal with any property comprising the Trust Fund.
- (iv) To open account in the name of the Trust, with a bank or bank to operate such account and to give instructions to the Bank and to provide for opening the operation of such account by one or more of the Trustees or by an agent appointed by the Trustees.
- (v) To adjust, settle, compromise, compound refers to arbitration, all actions, suits claims, demands and proceedings regarding the Trust fund.
- (vi) To engage or make provision for the engagement of any person (including all or any of the Trustees and committees or administrator or settler cum presidents or otherwise) for the purpose of the administration of the Trust in such manner and subject to such rules and regulation as the Trustees may prescribe and also to engage or provide for the engagement.
- (vii) To make very alter or modify schemes, rules and regulations for carrying out the objects of the Trust and for the management of the affairs thereof and / or running any institutions in furtherance of the objects of the Trust and otherwise for giving effect to the object of the trust.
- (viii) To start, abolish, discontinue and restart any charity of charitable institutions for the benefit of general public and to impose any conditions to any subscription or donation made by them.
- (ix) To set apart and / or allocate the whole or a part of the income or the corpus of the Trust Fund or the part thereof for any of the objects of the Trust.

(x) To join, to operate or amalgamate this Trust with other of others having kindred or allied objects, upon such terms and conditions as the Trustees may in their discretion think fit particularly having regard to and in conformity with the objects and nature of this trust.

(xi) To give aid by way of donations out of the income or the corpus of the Trust fund or otherwise to different charitable institutions, societies organizations or Trust in India which may have been established or which may hereinafter be established of the like charitable purposes mentioned in these presents or any of them to enable such institutions, societies, organization or Trustees to start maintain, or carry out such charitable objects.

(xii) To settle all accounts and to compromise, abandon, or refer too arbitration any action or proceedings or disputes, claim, demand or things, as deemed proper for such purpose without being responsible for any loss occasioned thereby.

(xiii) To borrow money either on the security of any property comprised in the Trust Fund or otherwise for all or any of the purposes of these presents, and it shall be lawful for the Trustee to make such borrowings on payment of such interest and otherwise on such terms and conditions as they may in their absolute discretion think fit.

(xiv) To apply to the Government, public bodies, urban local municipal, district and other bodies, corporation, companies, or persons for and to accept grant of money and of aid, donations, gifts, subscription, affiliation and other assistance including lease and substance of property with a view to promote the objects of the Trust and to discuss and negotiate with the Government Departments, public and other bodies corporations, companies or persons, scheme and other work and matters within the

objects of the Trust and to put to any proper condition upon which such grants and other payments including taking land on lease may be made.

- (xv) To take over or amalgamate with any other Charitable Public Trust, Trust, association, or institution with similar objects.
- (xvi) To take over, acquire, manage, control or aid any existing institutions or institutions having objects either wholly or in part similarly to the objects of this Trust and on such terms and conditions as may be thought expedient.
- (xvii) To purchase or otherwise acquire and undertake all or any part of the property, assets, liabilities and engagement of any or more of the trusts, societies institutions or associations with which this Trust is authorized to amalgamate.
- (xviii) To take land / property on lease and then after sublease the land / property to the farmers and other organizations like cooperative / society / urban public bodies, / gram panchayat or any being thereof in rural area / local municipal / district and other bodies corporation / company for farming / agriculture / plantation purposes.

10. These Trustees shall be accountable only for such money, and funds, which will actually come into their hands
11. The Trustees will not be entitled to receive any remuneration but the Trustee may reimburse themselves all expenses actually incurred by them in connection with the Trust or their duties relating thereto.
12. The Settler cum Chairman for the time being will be at liberty to appoint additional Trustee within the number mentioned above for such period or on such terms as to retirement and reappointment as the trustees for the time being consider proper.

A PERSON SHALL CEASE TO BE A TRUSTEE EITHER :

- If he without leave of absence does not attend three consecutive meeting of the Trustees or for one calendar year whichever is longer or
- If he is requested to resign by 2/3 rd or as near thereto as possible of the remaining trustees.
- In the absence of Settler cum Chairman, the Secretary of the Trust's will take charge and function of Settler cum Chairman.

14. Every Trustee will be at liberty to resign on giving one month's notice of his intention to do so.

The Trustees may from time to time frame rules of the conduct and regulations of the meetings of Trustees. In the absence of such regulations.

- (a) Five Trustees shall form a quorum for a meeting of the Trustees.
- (b) All matters will be decided mutually by the Trustee.
- (c) Resolution passed without any meeting of the Trustees but by circulation thereof and evidenced in writing under the hands of two thirds of the trustees shall be as valid and effectual as a Resolution duly passed at a meeting of Trustees.

15. The Trustees shall have the power to determine in case of doubt whether any money or property shall for the purpose of the charity be considered as capital or income and whether out of income or capital any expenses or outgoing ought to be paid or borne and every such determination shall be binding and conclusive provided that nothing constrained shall be deemed

to authorize the Trustees to spend the income or corpus of the Trust for any purpose not authorized by these present.

16. The accounting year of the Trust shall be the financial year ending on 31st March every year.
17. The Trust and the Trust funds shall be irrevocable for all the times.
18. It is expressly declared that no part of the Trust property or its income or any accretion thereto shall be applied for any purpose outside India or for any purpose which is not a Charitable purpose in law, and all provisions thereof shall be construed accordingly.
19. Working areas of the trust will be all over India and all other countries.
20. Two thirds majority shall continue the office of the Trust at **Nalanda** unless changed by the Trustees.

21. **POWER & FUNCTION OF THE OFFICE BEARER.**
SETTLER CUM CHAIRMAN.

The Settler – cum- Chairman shall preside at all meeting of the trust, when he is present and shall exercise such other powers as are conferred upon him by these rules, the Settler – cum- Chairman may call for an emergency meeting through Settler – cum- Chairman signed notice in a shorter period. The decision of Settler – cum- Chairman that a resolution has been carried or lost shall be conclusive, unless such a decision is challenged and a poll is demanded, on poll being demanded, the same shall be taken in such manner as the Settler – cum- Chairman may in discretion determine. In case of a tie the Settler – cum- Chairman shall have a second or casting vote.

TRUSTEE TREASURER

- i. He/She will receive grants, funds, donations and subscriptions on behalf of the Trust.

All registers will be kept in the registered office. Any member may inspect these registers with the prior permission of the Settler - cum- Chairman

23. AMENDMENTS :

Any additions, alterations, or omission in the objects and Rules and Regulations of the society shall be effected by resolution of the Trust by 3/5th member of the General body at a special general body meeting of the society.
